Town of Spring Grove Property Tax payments should be mailed to Green County Treasurer's Office for both installments (**1st installment due Thursday, January 31, 2019 and 2nd installment due Wednesday, July 31, 2019**). The Green County Treasurer's Office will be closed Monday, Dec. 24, 2018 and Tuesday, Dec. 25, 2018 and Tuesday, January 1, 2019. **Payment stubs are at the bottom of the tax bill (includes 1st installment and 2nd installment amounts).**

DOG LICENSES can be mailed to Spring Grove Township Treasurer, N780 Oakley Road, Juda, WI 53550. Please mail Proof of Rabies Vaccine. Be sure to include a self-addressed, stamped envelope for the return of your license and tags. Cost is \$4 for neutered/spayed and \$9 unneutered/unspayed. Multiple dog licenses are \$35.

DOG LICENSES CAN NOW BE PURCHASED ALL YEAR BY MAILING THE INFORMATION TO THE ABOVE ADDRESS

PLEASE BE SURE TO RETURN PAYMENT STUB OF YOUR TAX BILL WITH YOUR PAYMENT (at the bottom of the tax bill). Receipts will only be mailed when

a self-addressed, stamped envelope is included with your payment. If you prefer to pay by Credit Card go to www.co.green.wi.gov and use the "Pay Taxes Online" quick link. A convenience fee of 2.39% is charged for paying by credit card.
