Town of Spring Grove Property Tax payments should be mailed to Green County Treasurer's Office for both installments (1<sup>st</sup> installment due Friday, January 31, 2020 and 2<sup>nd</sup> installment due Friday, July 31, 2020). The Green County Treasurer's Office will be closed Tuesday, Dec. 24, 2019 and Wednesday, Dec. 25, 2019 and Wednesday, Jan. 1, 2020. Payment stubs are at the bottom of the tax bill (includes 1<sup>st</sup> installment and 2<sup>nd</sup> installment amounts).

DOG LICENSES can be mailed to Spring Grove Township Treasurer, N780 Oakley Road, Juda, WI 53550. Please mail Proof of Rabies Vaccine. Be sure to include a self-addressed, stamped envelope for the return of your license and tags. Cost is \$4 for neutered/spayed and \$9 unneutered/unspayed. Multiple dog licenses are \$35.
