September 2018 minutes read. Motion made to approve minutes by Fritz Badertscher and 2nd by Ernie Webnar. All in favor. Motion Carried.

Treasurer's report read. Motion made to approve Treasurer's report by Ernie Webnar, 2nd by Fritz Badertscher. All in favor. Motion Carried.

Review monthly bills and transfer \$22,000.00 to checking account. Motion made to approve the transfer of funds by Ernie Webnar and 2nd by Fritz Badertscher. All in favor. Motion Carried.

Driveway Permit: Josh & Jamie Riese presented driveway permit for new residence on Preston Road. Motion made by Ernie Webnar and 2nd by Fritz Badertscher to approve driveway permit as presented. All in favor. Motion Carried. They will need a 24' culvert at end of driveway.

Renewal of ATV Route: Discussed renewal of ATV route from Jefferson Township line to County Hwy OK on Town Center Road. Motion made by Fritz Badertscher and 2nd by Ernie Webnar to renew this portion of the road as ATV route for one more year. All in Favor. Motion carried.

Tax Collection Agreement with Green County Treasurer: Motion made by Ernie Webnar and 2nd by Fritz Badertscher to approve Tax collection agreement as written again this year for Tax Collections by the County in 2019.

Clearing Fence Line at the Town Hall. Resident in area concerned about fence obstructing sight when he comes out of the driveway. Board recommended taking out the fence line when time and weather permits.

Road Projects: intersection of Town Center Road and Mill Road - ditchline needs to be cleared out and possibly put in a new larger culvert. We will look at working on this project next year. County work: paver patching done; Kevin cleared out ditch by Wengers Bunker; Culvert put in at Mill Road and Kaderly Road - shaped and removed dirt into field.

Employee Review: Motion made by Fritz Badertscher and 2nd by Ernie Webnar to increase Hwy Patrolman wages to \$21.50. Boot allowance will stay the same at \$150.00 per year and Retirement Contribution will stay the same at 8 1/2 %. All in favor. Motion Carried. All other benefits (Holiday pay, etc.) will remain the same. Part-time snowplow driver wages also will stay the same as last year. WE are currently looking for a part time snowplow driver. Deb Cline will advertise in the next few weeks for this position.

Equipment Repairs: starter on White Tractor does not work - Pat Faessler will work on to repair; Spreader on Plow truck needs repairs
